Guidelines to Authors

The Shaheed Bhagat Singh College welcomes original research papers / articles for its Annual Journal "**JOURNAL OF BUSINESS STUDIES - 2012, VOL-V**" from both academicians and practitioners of Business, Management and related areas. Papers based on theoretical/empirical research and experience should satisfy good quality research and must reflect the practical applicability of the research

Text Preparation: Authors should send One copy of the manuscript along with one-self addressed stamped envelope. The text should be double spaced on A4 size paper with one-inch margin all around. The author's name should not appear anywhere in the body of the manuscript to facilitate the blind review process. An abstract of 200 words and a brief biographical sketch of the author should accompany the manuscript on separate sheets. Research articles should be of 20-40 pages including tables, figures and exhibits. The authors should send a declaration stating that the paper is neither published nor under consideration for publication elsewhere.

All tables, charts and graphs should be black and not in colour. Wherever necessary, the source should be indicated at the bottom. Number and complexity of such exhibits should be as low as possible. All charts and graphs should be drawn cleanly and legible and figures should be indicated in million and billion. Tables and figures should contain self-explanatory titles. Footnotes, Itablics, and Quotation Marks should be kept to the minimum.
